Police Act, **No.GHG/162/MTS/102010/806/C1:-** In exercise of the powers conferred by clause (b) of 1951.

section 5 of the Gujarat Police Act, 1951 (Bom. XXII of 1951), the Government of Gujarat, hereby makes the following rules further to amend the Police Sub-Inspector (Motor Transport), Class-III, in the subordinate service of the Police Department, Recruitment Rules, 2015, namely: -

1 . (1) These rules may be called the Police Sub-Inspector (Motor Transport), Class-III, in the subordinate service of the Police Department, Recruitment (First Amendment) Rules, 2023.

(2) They shall come into force on the date of their publication in the *Official Gazette*.

2 . In the Police Sub-Inspector (Motor Transport), Class-III, in the subordinate service of the Police Department, Recruitment Rules, 2015, in rule 4, in clause (b), for sub-clause (iii), the following sub-clause shall be substituted, namely:-

A valid motor driving licence of heavy goods or heavy passenger vehicles at the time of appointment.
