No.GHG/88/MHK/e-file/8/2024/2943/C1:- In exercise of the powers conferred by clause (b) of section 5 of the Gujarat Police Act, 1951 (Bom. XXII of 1951), the Government of Gujarat hereby makes the following rules further to amend the Head Constable Driver Mechanic (Grade I), Class III, in the Motor Transport Organization of the Police Department, Recruitment Rules, 2016, namely:-

1.(1) These rules may be called the Head Constable Driver Mechanic (Grade I), Class III, in the Motor Transport Organization of the Police Department, Recruitment (Amendment) Rules, 2024.

(2) They shall come into force from the date of their publication in the *Official Gazette*.

2. In the Head Constable Driver Mechanic (Grade I), Class III, in the Motor Transport Organization of the Police Department, Recruitment Rules, 2016 (hereinafter referred as "the said rules"), in rule 3, for clause (v), the following clause shall be substituted, namely:-

"(v) possess a valid motor driving licence of heavy goods or heavy passenger vehicles at the time of appointment;"

3. In the said rules, in Appendix 'A', for clause A under the heading "All Male Candidates" and for clause B under the heading "All Female Candidates" the following clauses respectively, shall be substituted, namely:-

"A. For Male Candidates:

Class	Height in Centimetres	Chest in centimetres	
		Deflated	Inflated. *
Scheduled Tribes candidates of Gujarat origin.	162	79	84
Candidates (except Scheduled Tribes of Gujarat origin)	165	79	84

* Minimum expansion of chest when inflated shall not be less than 5 centimetres.

B. For Female Candidates:

Class	Height in centimetres
Scheduled Tribes candidates of Gujarat origin.	150
