## Constitution of India.

No. G/G/30/2024/FSL/102024/119/A:- In exercise of the powers conferred by the proviso to article 309 of the constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Police Photographer, Class III, in the subordinate service under the Directorate of Forensic Science, Gujarat State, namely:-

- (1) These rules may be called the Police Photographer, Class III, under the Directorate of Forensic Science, Recruitment Rules, 2024.
  - (2) They shall come into force from the date of their publication in the *Official Gazette*.
- 2. Appointment to the post of Police Photographer, Class III, in the subordinate service under the Directorate of Forensic Science, Gujarat State shall be made by direct selection.
- 3. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall, -

(a) not be more than 33 years of age:

Provided that the upper age limit may be relaxed in favor of the candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;

- (b) have passed the Higher Secondary School Certificate Examination with Science subject from Secondary and/or Higher Secondary Board or possess an equivalent qualification recognised as such by the Government;
- (c) possess the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;

(d) (i) possess about two years' experience in indoor and outdoor photography;

(ii) have a knowledge of qualities of various type of photographic materials and equipment; and

(iii) be conversant with various specified photographic process such as photography of documents with use of Transmitted Light, Ultraviolet and Infrared Film, Micro Photography, movie photography and working knowledge with 16mm sound projectors; and

- (e) possess the adequate knowledge of Gujarati or Hindi or both.
- 4. The provisions of rule 9A of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 shall be applicable in respect of the candidate appointed by direct selection.
- 5. The candidate appointed by direct selection shall be required to undergo such training and pass such examination as may be prescribed by the Government.
- 6. The candidate appointed by direct selection shall be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.
