PrisonNo. GG-11/2021/JLM/502007/3105/J:-:- In exercise of the powers conferred by clauseAct, 1894(10) of sub section (1) of section 59 read with section 6 of the Prisons Act, 1894 (9 of
1894), and in supersession of all the rules made in this behalf, the Government of Gujarat
hereby makes the following rules to provide for regulating recruitment to the post of
Deputy Superintendent, Central Prison/ Principal, Jail Staff Training School, Class I, in
the Gujarat State Jail Service under the office of Inspector General of Prisons and
Correctional Administration namely :-

- 1. These rules may be called the Deputy Superintendent, Central Prison/ Principal, Jail Staff Training School, Class I, Recruitment Rules, 2021.
- 2. In these rules unless the context requires Superintendent, District Prison, Class II, means the posts included in the Annexure-I Annexed to these rules.
- 3. Appointment to the post of Deputy Superintendent, Central Prison/ Principal, Jail Staff Training School, Class I in the Gujarat State Jail Service under the office of Inspector General of Prisons and Correctional Administration shall be made either,-
 - (a) by promotion of a person who possess 'good' benchmark for being considered fit for promotion within the zone of consideration as laid down in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 from amongst the persons' who,-
 - (i) have worked for not less than eight years in the cadre of Superintendent, District Prison, Class II in the Gujarat State Jail Service under the office Inspector General of Prisons and Correctional administration; and
 - (ii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006:

Provided that where the appointing authority is satisfied that a person having the experience specified in sub-clause (i) above is not available for promotion and that it is necessary in the public interest to fill up the post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two- thirds of the period specified in sub-clause (i) above; or; (b) by temporary transfer on deputation basis from amongst the persons working on the cadre of Gujarat Administrative Service, Junior Scale, Class I, or Deputy Superintendent of Police, Class I, in the Gujarat State Police Service; or 4

- (c) by direct selection.
- 4. To be eligible for appointment by direct selection to the post mentioned in rule 3, a candidate shall,
 - (a) not be more than 40 Years of age:

Provided that nothing contained in clause (b) of sub-rule (9) of rule 8 of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 shall be applicable in so far as relaxation of upper age limit as prescribed above is concerned:

Provided further that the upper age limit may be relaxed in favour of a candidate of Schedule Castes, Scheduled Tribes, Socially and Educationally Backward Classes and Economically Weaker Sections and in favour of Women candidate in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967:

Provided also that upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;

- (b) possess,
 - a Bachelor's degree obtained from any of the Universities established or incorporated by or under the Central or a State Act in India; or any other educational institution recognised as such or declared to be a deemed as a University under section 3 of the University Grants Commission Act, 1956 or possess an equivalent qualification recognised by the Government; and
 - (ii) have about five years' experience of Jailor, Group I, Class II in the Gujarat State Jail Service under the office of Inspector General of Prisons and Correctional Administration or have about five years of experience in the field of administration in the Government / Government Undertaking / Board / Corporation / Local Bodies/ Limited Company established under the Companies Act 2013 which can be considered equivalent to the post not below the rank of Jailor Group I, Class II in the Gujarat State Jail Service under the office of the

Inspector General of the Prisons and Correctional Administration;

- (c) have fulfilled the minimum requisite criteria of physical standards as prescribed in Appendix 'A' appended these to these rules;
- (d) the basic knowledge of computer application as prescribed in Gujarat Civil Services Classification and Recruitment (General) Rules 1967; and
- (e) possess the adequate knowledge of Gujarati or Hindi or both.
- 5. The candidate appointed by direct selection shall be on probation for a period of two years.
- 6. The candidate appointed by direct selection shall, during his probation period, be required to undergo pre-service training and pass the post- training examination in accordance with the provisions of the Gazetted Officer's (Pre-Service Training and Examination)Rules, 1970.
- 7. The candidate appointed by direct selection shall, during his probation period, be required to pass the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006.
- 8. The candidate appointed by direct selection shall be required to pass an examination in Gujarati or Hindi or both in accordance with the rules prescribed by the Government.
- 9. The candidate appointed either by promotion or by direct selection shall be required to undergo such training and to pass such examination as may be prescribed by the Government.
- 10. The candidate appointed by direct selection shall be required to furnish a security and a surety bond in such form, for such amount and for such period as may be prescribed by Government.
- 11. Where in respect of any matter regarding service conditions of the Deputy Superintendent, Central Prison/ Principal, Jail Staff Training School, Class-I for which specific provision is not made either in the Prions Act 1894 or in these rules, the following rules which are applicable to the employees of the corresponding class of the Government of Gujarat, shall be *matatis-mutandis* apply to the Deputy Superintendent,Central Prison/ Principal, Jail Staff Training School Class-I, namely:-

B. All Female candidates shall be physically **fit** as per the standards for different classes of person as specified below:

1. The candidate having any of the following physical defects shall not be fit for the post, namely :-

(i) Knock Knee, (ii) pigeon chest, (iii) squint eye, (iv) flat feet, (v)varicose veins,(vi) hammer toes, (vii) fractured limb, (viii) decayed teeth, (ix) communicable, or(x) skin disease.

2. The Medical Officer shall, examine the candidate and issue the certificate of fitness taking into consideration the physical standards as mentioned above and also certify for the following matter, namely:-

3. The candidate shall be required to free from any surgical deformities like knockknees, flat-foot and should not have a past history of fits or psychiatric ailments, varicose vein, etc.
