No.GHG/39/2025/PWS/102008/1804/C1:- In exercise of the powers conferred by clause (b) of section 5 of the Gujarat Police Act, 1951 (Bom. XXII of 1951) and in supersession of all the rules made in this behalf, the Government of Gujarat hereby makes the following rules to provide for regulating the recruitment to the post of Police Sub-Inspector (Wireless), Class III, in the subordinate services of Police Department, namely:-

1. (1) These rules may be called the Police Sub-Inspector (Wireless), Class III, in the subordinate services of Police Department Recruitment Rules, 2025.
(2) They shall come into force from the date of their publication in the *Official Gazette*.
2. Appointment to the post of Police Sub-Inspector (Wireless), Class III, in the subordinate services of the Police Department shall be made either,-
 - (a) by promotion of a person who possesses "Good" benchmark for being considered fit for promotion within the zone of consideration laid down in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 from amongst the persons, who,-
 - (i) have worked for not less than five years in the cadre of Technical Operator, Class III, in the subordinate services of the Police Department;
 - (ii) have passed the departmental examination as may be prescribed by the Government; and
 - (iii) have passed the qualifying examination for computer knowledge in accordance with the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006:

Provided that where the appointing authority is satisfied that a person having the experience specified in sub-clause (i) above is not available for promotion and that it is necessary in the public interest to fill up a post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such persons who possess experience of a period of not less than two-thirds of the period specified in sub-clause (i) above; or
 - (b) on the basis of the result of competitive examination held for the purpose.
3. The appointment by promotion and on the basis of the result of competitive examination held for the purpose shall be made in the ratio of 1:1, respectively.
4. To be eligible for appointment on the basis of the result of competitive examination held for the purpose to the post mentioned in rule 2, a candidate shall,-

- (a) not be more than 35 years of age:

Provided that the upper age limit may be relaxed in favour of a candidate belonging to the Scheduled Castes, Scheduled Tribes, Socially and Educationally Backward Classes, Economically Weaker Sections and in favour of candidate who are Women in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967:

Provided further that the upper age limit may also be relaxed to the extent of three years in favour of a candidate who is working as a Technical Operator, Class III in the subordinate

service of Home Department;

(b) possess a Bachelor's degree in Engineering or Technology in Electronics and Communication / Electronics and Telecommunication / Electronics Engineering / Information Technology / Information and Communication Technology / Computer Engineering / Computer Science (minimum four years course) obtained from any of the Universities established or incorporated by or under the Central or a State Act in India or any other educational institution recognized by the Government or declared to be deemed as a University under section 3 of the University Grants Commission Act, 1956;

(c) possess the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967; and

(d) possess adequate knowledge of Gujarati or Hindi or both.

5. The provisions of rule 9A of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 shall be applicable in respect of a candidate appointed on the basis of the result of competitive examination held for the purpose.

6. The candidate appointed on the basis of the result of competitive examination held for the purpose shall have to undergo such training and pass such examination as may be prescribed by the Government.

7. The candidate appointed on the basis of the result of competitive examination held for the purpose shall be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.
