Police Act. 1951. No.GHG/?...1./2025/MHK/102018/2194/C :- In exercise of the powers conferred by clause (b) of section 5 of the Gujarat Police Act, 1951 (Bom. XXII of 1951), the Government of Gujarat hereby makes the following rules further to amend the Police Sub-Inspector (Unarmed), Class III (Departmental Examination) Rules, 2019, namely :-

1.(1) These rules may be called the Police Sub-Inspector (Unarmed), Class III (Departmental Examination) (Amendment) Rules, 2025.

(2) They shall come into force on the date of their publication in theOfficial Gazette.

2. In the Police Sub-Inspector (Unarmed), Class III (Departmental Examination) Rules, 2019, after rule 3, the following rule shall be inserted, namely :-

"3A. Conditions for eligibility to appear in examination for higher grade scale.-

Notwithstanding anything contained in these rules, where a Head Constable Unarmed) or a Constable (Unarmed) who is not promoted to the post of Assistant Sub-Inspector (Unarmed) and who is in receipt of the higher grade scale for the post of Assistant Sub – Inspector (Unarmed) for three years on the last date of accepting the application form, in such case, he shall be allowed to appear in the examination prescribed by these rules for the purpose of higher grade scale for the post of Police Sub-Inspector (Unarmed), Class III".
