Prisons No. GG-15/2021/JLM/502008/4921/J:-:- In exercise of the powers conferred by clause
Act, (10) of sub- section (1) of section 59 read with section 6 of the Prisons Act, 1894 (9 of 1894) and in supersession of all the rules made in this behalf, the Government of Gujarat hereby makes the following rules to provide for regulating the recruitment to the post of Jailor Group I (Male), Class II, in the Gujarat State Jail Service under the Office of Inspector General of Prisons and Correctional Administration, namely:-

- These rules may be called the Jailor Group I (Male), Class II under the Office of Inspector General of Prisons and Correctional Administration, Recruitment Rules, 2021.
- 2. Appointment to the post of Jailor Group I (Male), Class II, in the Gujarat State Jail Service, under the Office of Inspector General of Prisons and Correctional Administration, shall be made either,-
  - (a) by promotion of a person who possesses 'good' benchmark for being considered fit for promotion within the zone of consideration as laid down in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 from amongst the persons' who,-
    - (i) have worked for not less than seven years in the cadre of Jailor Group II (Male), Class III, in the subordinate service of the Gujarat State Jail Service under the Office of Inspector General of Prisons and Correctional Administration ;
    - (ii) have passed the prescribed departmental examination; and
    - (iii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006:

Provided that where the appointing authority is satisfied that a person having the experience specified in sub-clause (i) above is not available for promotion and that it is necessary in the public interest to fill up the post by promotion even of a person having experience for a lesser period, it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two-thirds of the period specified in sub- clause (i) above; or

- (b) by temporary transfer on deputation basis from amongst the persons working on the cadre of Police Inspector, Class II, in the Gujarat State Police Department or in the Gujarat State Reserve Police Force; or
- (c) by direct selection.
- 3. Appointment by direct selection and by promotion shall be made in the ratio of 1:3.
- 4. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall,-
  - (a) not be more than 35 years of age:

Provided that the upper age limit may be relaxed in favour of a candidate of a Scheduled Castes, Scheduled Tribes, Socially and Educationally Backward Classes and Economically Weaker Sections in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967:

Provided further that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;

- (b) possess,-
  - (i) a Bachelor's degree obtained from any of the Universities established or incorporated by or under the Central or a State Act in India; or any other educational institution recognised as such or declared to be a deemed as a University under section 3 of the University Grants Commission Act, 1956, or possess an equivalent qualification recognized by the Government;
  - (ii) the minimum requisite standard of physique as specified in Appendix 'A' appended to these rules;
  - (iii) the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;and

(iv) adequate knowledge of Gujarati or Hindi or both; and

(c) have passed the physical efficiency test as prescribed by the Government.

5. The candidate appointed by direct selection shall be on probation for a period of two years.

- 6. The candidate appointed by direct selection shall, during his probation period, be required to undergo pre-service training and to pass the post-training examination in accordance with the provisions of the Gazetted Officers Pre-Service Training and Examination Rules, 1970.
- The candidate appointed by direct selection shall during his probation period be required to undergo basic training and to pass the post-training examination in Prison Academy Vellore, Tamil Nadu.
- 8. The candidate appointed by direct selection shall during his probation period, be required to pass the qualifying examination for computer knowledge in accordance with the provisions of the Gujarati Civil Services Computer Competency Training and Examination Rules, 2006.
- 9. The candidate appointed by direct selection shall be required to pass an examination in Hindi or Gujarati or both in accordance with the rules prescribed by the Government.
- 10. The candidate appointed either by promotion or by direct selection shall be required to undergo such training and pass such examination as may be prescribed by the Government.
- 11. The candidate appointed by direct selection shall be required to furnish a security and a surety bond in such form, for such amount and for such period as may be prescribed by the Government.
- 12. Where in respect of any matter regarding service conditions for the post of Jailor Group I (Male), Class II, for which specific provisions are not made either in the Prisons Act,1894 or in these rules, the following rules which are applicable to the employees of the corresponding class of the Government of Gujarat, shall, matatis-mutandis apply to the post of Jailor Group-I (Male), Class II, whom these rules are applicable; namely:-
  - (a) The Gujarat Civil Services Classification and Recruitment (General) Rules, 1967.
  - (b) The Gujarat Civil Services (Pay) Rules, 2002.
  - (c) The Gujarat Civil Services (Additions to Pay) Rules, 2002.
  - (d) The Gujarat Civil Services (General Conditions of Service) Rules, 2002.
  - (e) The Gujarat Civil Services (Travelling Allowance) Rules, 2002.
  - (f) The Gujarat Civil Services (Occupation of Government Residential Accommodation) Rules, 2002.
  - (g) The Gujarat Civil Services (Leave) Rules, 2002.
  - (h) The Gujarat Civil Services (Pension) Rules, 2002.

## Appendix 'A'

## (see rule 4(b)(ii))

Minimum Physical Standards required for the post of Jailor Group-I (Male), Class II in the Gujarat State Jail Service, under the Office of Inspector General of Prisons and Correctional Administration.

A. All Male candidates shall be physically fit as per standards for different classes of persons as specified below:

Class	Height	Chest*(minimum)		Weight
	(minimum)	Deflated	Inflated	(minimum)
Scheduled Tribes candidates of Gujarat origin.	160 Centimeters.	79 Centimeters	84 Centimeters.	50 kilogram.
Candidates except Scheduled Tribes of Gujarat origin.	165 Centimeters.	79 Centimeters	84 Centimeters.	50 kilogram.

\* Minimum expansion of chest when inflated shall not be less than 5 centimeters.

**B.** The candidate having any one or more of the following physical defects shall be considered physically unfit for the post:

(i) Knock knee (ii) Pigeon Chest (iii) Squint Eye (iv) Flat Feet (v) Varicose Veins(vi) Hammer Toes (vii) Fractured Limb (viii) Decayed Teeth (ix) CommunicableSkin Disease.

**C.** The Medical Officer shall, examine the candidates and issue the Certificate of Fitness taking into consideration the physical standards as mentioned above and also certify for the following matters, namely:-

SHAPEI Means

- S Psychological
- H Hearing
- A Appendage
- P Physical capacity for normal work
- E Eye sight
- I Means fit in all respect to perform normal professional functions under each of the above mentioned heads.

**D.** The candidates shall be required to free from any surgical deformities like knockknees, flat-foot and shall not have a past history of fits or psychiatric ailments, varicose veins, etc.
