No. G/G/100/2018/FSL/102008/1792/A: - In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules further to amend the Scientific Officer Class II, (in the Directorate of Forensic Science) Recruitment Rules, 2015, namely:-

- 1. These rules may be called the Scientific Officer, Class II, (in the Directorate of Forensic Science) Recruitment (Amendment) Rules, 2018.
- 2. In the Scientific Officer, Class II, (in the Directorate of Forensic Science) Recruitment Rules, 2015(after herein referred to as "the said rules") in Rule 4,-

(i) in clause (a), for the figures and word "40 years", the figures and word "37 years" shall be substituted;
(ii) in clause (b),-

(a) for sub-clause (i) the following sub-clause shall be substituted, namely:-

"(i) a post-graduate degree as specified in Annexure annexed to these rules for respective group of sections/divisions obtained from any of the Universities established or incorporated by or under the Central or a State Act in India; or any other educational institution recognized as such or declared to be deemed as University under section 3 of the University Grants Commission Act, 1956; or";

(b) in sub-clause (ii),-

(a)in para (A) for the words "five years" the words "two years" shall be substituted;

(b) for para (B), the following para shall be substituted namely;

"(B) have about two years' experience of research or analytical work in the respective subject in the Government or local bodies or Government Undertaking Board or corporation or private or public sector laboratory or research institute or limited company established under the Companies Act, 2013 or University or college on the post which can be considered equivalent to the post not below the rank of the Laboratory Technician, Class III, in the subordinate service of the Directorate of Forensic Science, Gujarat State;".

- 3. in the said rules, after rule 5, the following rule shall be inserted namely;
 "5A. The candidate appointed by direct selection shall, during his probation period, be required to undergo pre-service training and to pass the post-training examination as may be prescribed by the Government".
- 4. In the said rules, for the existing Annexure, the following Annexure shall be substituted, namely:-
