### Code of Criminal Procedure, 1973.

No.GG/ 147/PST/102013/667/C :- In exercise of the Powers Conferred by clause (s) of Section 2 of the Code of Criminal Procedure, 1973(2 of 1974) in its application to the State of Gujarat, the Government of Gujarat, hereby amends the Government Notification, Home Department No.GG/8/PST/102013/667/V, dated the 23<sup>rd</sup> January, 2014, as under:


