## NOTIFICATION

Prisons Act, 1894

No. GG-116/2024/JLM/2764/J: In exercise of the powers conferred by sub-section (10) of section 59 read with section 6 the Prisons Act, 1894 (IX of 1894), the Government of Gujarat hereby makes the following rules further to amend the Jailor Group-II (Male), class-III, Recruitment Rules, 2015, namely:-

- 1. (1) These rules may be called the Jailor Group-II (Male), Class III, Recruitment (Amendment) Rules, 2024.
  - (2) They shall come into force from the date of their publication in the official Gazette.
- 2. In the Jailor Group-II (Male), Class III, Recruitment Rules, 2015 (hereinafter referred to as "the said rules") in rule-2, in clause (a),-
  - (i) for the words, "by promotion of a person of proved merit and efficiency", the words, brackets and figures "by promotion of a person who possesses 'Good' benchmark for being considered fit for promotion within the zone of consideration as laid down in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967" shall be substituted;
  - (ii) after sub-clause (ii), the following sub-clause shall be added, namely:-
    - "(iii) possess a valid heavy or light motor vehicle driving licence:".
  - 3. In the said rules, in rule 4,-
    - (i) in clause (a), for the words and figure "not be less than 21 years and more than 35 years of age" the words and figure "not more than 35 years of age" shall be substituted;
    - (ii) in clause (b), for the words "a degree", the words "a Bachelor's degree" shall be substituted;
    - (ii) in clause (f), for the words "Gujarati or Hindi", the words "Gujarati or Hindi or both" shall be substituted.
    - (iv) after clause (f), the following clause (g) shall be added, namely:-"g) Possess a valid heavy/light motor vehicle driving licence.".
    - (v) the existing proviso shall be deleted.
  - 4. In the said rules, in rule 9, the words "after regular appointment" shall be deleted.

5. In the said rules, in Appendix 'A', under the heading "Physical Standards for different classes of person", for clause (i), the following clause shall be substituted, namely: -

"(i) All the candidates shall be physically fit as per standards as specified below:
