No.GG/69/21/FSL/102008/1820/A:- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules further to amend the Laboratory Technician, Class III, (in the Directorate of Forensic Science) Recruitment Rules, 2015, namely:-

1. These rules may be called the Laboratory Technician (in the Directorate of Forensic Science) Recruitment (Amendment) Rules, 2021.
2. In the Laboratory Technician, Class III, (in the Directorate of Forensic Science) Recruitment Rules, 2015 (hereinafter referred to as “the said rules”), in rule 2,-
  - (i) in clause (a), for the words “by promotion of a person of proved merit and efficiency” the words, brackets and figures ‘ by promotion of a person who possess “good” benchmark for being considered fit for promotion within the zone of consideration as laid down in the Gujarat Civil Services Classification and recruitment (General ) Rules, 1967”, shall be substituted ;
  - (ii) for sub-clause (i) the following sub-clause shall be substituted, namely:-

“(i) have worked for not less than five years in the cadre of Laboratory Assistant, Class III, in the respective sections/divisions in the subordinate service of the Directorate of Forensic Science, Gujarat State and possess a degree as specified in Annexure-annexed to these rules for respective group of sections/divisions.’.
3. In the said rules, in rule 3, in clause (a), for the figures and word “30 years” the figures and word “35 years’, shall be substituted.
