Constitution of India No.GG/98/2021/JLM/502019/2404/J:- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating the recruitment to the post of Superintendent of Jail Industries, Class-II, in the General State Service, in the office of the Inspector General of Prisons and Correctional Administration, namely:-

1. These rules may be called the Superintendent of Jail Industries, Class II, in the office of the Inspector General of Prisons and Correctional Administration, Recruitment Rules, 2021. 2. Appointment to the post of Superintendent of Jail Industries, Class-II, in the General State Service in the office of the Inspector General of Prisons and Correctional Administration shall be made by promotion of a person who possesses 'Good' benchmark for being considered fit for promotion within the zone of consideration as laid down in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 from amongst the persons, who, -

- (i) have worked for not less than seven years on the post of Weaving Master/Factory Manager/Sales Manager/Industry Superintendent (Non Textile), Class III, in the subordinate service of under the office of the Inspector General of Prisons and Correctional Administration, Gujarat State; and
- (ii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006:

Provided that, where the appointing authority is satisfied that person having the experience specified in sub-clause (i) above is not available for promotion and that it is necessary in the public interest to fill up the post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two-thirds of the period specified in sub-clause (i) above.

3. The candidate appointed by promotion shall be required to undergo such training and to pass such examination as may be prescribed by the Government.
