No.GG/60/2024/FSL/102008/1902/A:- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules further to amend the Deputy Chief State Examiner of Questioned Documents, Class II, in the Questioned Document Division, Recruitment Rules, 2018, namely:-

1. (1) These rules may be called the Deputy Chief State Examiner of Questioned Documents, Class II, in the Questioned Document Division, Recruitment Rules, 2024.
(2) They shall come into force from the date of their publication in the *Official Gazette*.
2. In the Deputy Chief State Examiner of Questioned Documents, Class II, in the Questioned Document Division, Recruitment Rules, 2018 (hereinafter referred to as "the said rules"), in rule 2, in clause (a), for the words "by promotion of a person of proved merit and efficiency", the words, brackets and figures, "by promotion of a person who possesses 'Good' benchmark for being considered fit for promotion within zone of consideration as laid down in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967" shall be substituted.
3. In the said rules, in rule 3, in clause (c), for sub-clause (ii), the following sub-clause shall be substituted, namely:-
“(ii) have about five years’ experience in the field of Scientific Examination of Questioned Documents in the State or Central Forensic Science Laboratory or Government/Local bodies/Government Undertaking Board /Corporation / Limited Company established under the Companies Act, 2013 on the post which can be considered equivalent to the post not below the rank of the Assistant Examiner of Questioned Documents, Class III, in the Questioned Document Division in the subordinate service, under the Directorate of Forensic Science, Gujarat State;”.
