Gujarat Police No.GHG/102/2024/PWS/102024/1031/C1:- In exercise of the powers conferred by clause (b) of section 5 of the Gujarat Police Act, 1951 (Bom. XXII of 1951) and in supersession of all the rules made in this behalf, the Government of Gujarat hereby makes the following rules to provide for regulating the recruitment to the post of Technical Operator, Class III, in the subordinate services of Police Department, namely: -

- 1. (1) These rules may be called the Technical Operator, Class III, in the subordinate services of Police Department Recruitment Rules, 2024.
 - (2) They shall come into force from the date of their publication in the Official Gazette.
- 2. Appointment to the post of Technical Operator, Class III, in the subordinate services of the Police Department shall be made on the basis of the result of competitive examination held for the purpose.
- 3. To be eligible for appointment on the basis of the result of competitive examination held for the purpose to the post mentioned in rule 2, a candidate shall,-

(a)not be more than 35 years of age:

Provided that the upper age limit may be relaxed in favour of a candidate belonging to the Scheduled Castes, Scheduled Tribes, Socially and Educationally Backward Classes, Economically Weaker Sections and in favour of candidate who are Women in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 :

Provided further that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) rules, 1967

(b) possess a Bachelor's degree in Engineering or Technology in Electronics and Communication / Electronics and Telecommunication /Electronics Engineering / Information Technology/Information and Communication Technology/Computer Engineering / Computer Science (minimum four years course) obtained from any of the Universities established or incorporated by or under the Central or a State Act in India or any other educational institution recognized by the Government or declared to be deemed as a University under section 3 of the University Grants Commission Act, 1956;

(c) possess the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967; and

(d) possess adequate knowledge of Gujarati or Hindi or both.

- 4. The provisions of rule 9A of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 shall be applicable in respect of a candidate appointed on the basis of the result of competitive examination held for the purpose.
- 5. The candidate appointed on the basis of the result of competitive examination held for the purpose shall have to undergo such training and pass such examination as may be prescribed by the Government.
- 6. The candidate appointed on the basis of the result of competitive examination held for the purpose shall be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.
