Provided that where the appointing authority is satisfied that a person having the experience as specified in sub clause (i) above is not available for promotion and that it is necessary in the public interest to fill up the post by promotion even of a person having experience for a lesser period: it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two thirds of the period specified in sub clause (i) above; or,

- (c) have atleast 5 years administrative experience on a post not lower than Office Suprintendent or equivalent, under the State or Central Government or a post in private or joint sector or Government undertaking which can be treated equivalent to Office Suprintendent considering the pay scale, duties and responsibilities;
- (d) possess adequate knowledge of Gujarati and or/ Hindi:

Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civi Services Classification and Recruitment (General) Rules, 1967.

The candidate appointed by direct selection shall be on probation for a period of two years. The candidate appointed by direct selection shall during his probation period be required to undergo pre-service training and to pass the post training examination in accordance with the Gazetted Officers Pre-Service Training and Examination Rules, 1970.

- The candidate appointed by direct selection shall during his proba ion period be required to 6 pass the qualifying examination for computer knowledge in accordance with the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006
- The candidate appointed by direct selection shall be required to pass an examination in Hindi 7 or Gujarati or both in accordance with the rules prescribed by the Government.
- The candidate appointed either by promotion or by direct selection shall have to undergo such 8 training and pass post training examination in accordance with the rules as may be prescribed by the Government.
