No. GG/2010/15/PWS/102008/1806/A: In exercise of the powers conferred by clause (b) of section 5 of the Gujarat Police Act, 1951(Bom. XXII OF 1951) and in supersession of all the rules made in this behalf, the Government of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of **Police Inspector (Wireless)**, in the Gujarat State Police service, class II, in the Police Wireless Organization of the Police Department, namely:-

1. These rules may be called the **Police Inspector (Wireless), class II,** in the Police Wireless Organization Recruitment Rules, 2013.

2. Appointment to the post of Police Inspector (Wireless) in the Gujarat State Police Service, class II, in the Police Wireless Organization of the Police Department shall be made either;-

(a) by promotion of a person of proved merit and efficiency from amongst the persons who,-

(i) have worked for not less than seven years in the cadre of Police Sub-Inspector (Wireless), Class III, in the Gujarat State Police Service:

Provided that where the appointing authority is satisfied that a person having the experience specified above is not available for promotion and that it is necessary in the public interest to fill up the post by promotion even if a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two- thirds of the period specified above: and

(ii) have passed the qualifying examination for computer knowledge in accordance with the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006; or

(b) by direct selection.

3. To be eligible for appointment by direct selection to the post mentioned in rule-2, a candidate shall, -

(a) not be less than 21 years of age and not be more than 31 years of age;

(b) Possess a Bachelor's degree in Engineering in Electronics and Communication or Electronics and Telecommunication or Electronics or Information Technology obtained from any of the Universities established or incorporated by an Act of the Parliament or a State Legislature in India or any other educational institution recognized as such by the Government or declared to be deemed as University under section 3 of the University Grants Commission Act,1956 (3 of 1956) or an equivalent qualification recognized as such by the Government.

(c) Possess the basic knowledge of computer application as prescribed in Gujarat Civil Services Classification and Recruitment (General) Rules 1967 as amended from time to time in that behalf;

(d) (i) have about three years experiences on the post not below the rank of Radio Operator, Class III, or Radio Technician, Class III, in the Gujarat State Police Service in the Police Wireless organisation in the subordinate service of the Police Department: **or**

(ii) have about three years combined or separate experiences in the field of Radio Engineering or Telecommunication or Electronics and Communication or Electronics or maintenance of wireless equipments in Government Department or local bodies or Government owned, Board or Corporation or Public Sector Under Taking or a Limited company established under the Companies Act,1956 on the post which can be considered equivalent to the post not below the rank of the Radio Operator, Class III, or Radio Technician, Class III, in the Gujarat State Police Service, in the Police wireless Organisation in the subordinate service of the Police Department;

(e) Possess the minimum requisite standard of physique as specified in Appendix-A annexed to these rules; and

(f) Possess adequate knowledge of Gujarati or Hindi or both.

4. The candidate appointed by direct selection shall be on probation for a period of two years.

5. The candidate appointed by direct selection shall, during his probation period, be required to pass the qualifying examination for Computer Knowledge in accordance with the provision of the Gujarat Civil Services Computer Competency (Training and Examination) Rules, 2006.

6. The Selected candidate shall be required to undergo departmental training of three months and field training of nine months under the supervision of Director General of Police (Technical Services).

7. The candidate appointed by direct selection shall be required to pass an examination in Gujarati or Hindi or both in accordance with the rules prescribed by Government in that behalf.

8. The candidate appointed either by direct selection or by promotion shall have to undergo such training and to pass such examination as may be prescribed by the Government

9. The candidate appointed either by direct selection shall be required to furnish a Security and surety bond in such form, for such period and for such amount as may be prescribed by Government in that behalf.
