No.GG/86/2009/MKM/102007/267(PT-IV)/E-1: - In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating the recruitment to the post of Superintendent of Prohibition and Excise, Class II in the General State Service, namely:-

1. These rules may be called the Superintendent of Prohibition and Excise, Class II, Recruitment Rules, 2009.

2. Appointment to the post of Superintendent of Prohibition and Excise, Class II (Prohibition and Excise Department) in the General State Service shall be made either -

(1) by promotion of a person of proved merit and efficiency from amongst the persons who -

(a) have worked for not less than seven years in the cadre of Inspector of Prohibition and Excise in the subordinate service of the Directorate of Prohibition and Excise Department:

Provided that where the appointing authority is satisfied that a person having the experience as specified above is not available for promotion and that it is necessary in the public interest to fill up the post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two-thirds of the period specified above;

(b) have passed the prescribed departmental examination;

(c) have passed the qualifying examination for computer knowledge in accordance with the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006; and

(d) have passed the Police Training Examination:

Provided that the Inspector of Prohibition and Excise, Class III, who have passed the Police Training Examination at the time of promotion as a Inspector of Prohibition and Excise or during his probation period shall not require to pass the Police Training Examination.

(2) by direct selection.

3. The appointment by direct selection and promotion shall be made in the ratio of 1:2, respectively.

4. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall,-

(a) not be more than 28 years of age;

(b) possess a degree obtained from any of the University or an Institution established or incorporated by an Act of the Parliament or a State Legislature in India or an institution declared to be deemed as a University under section 3 of the University Grants Commission Act, 1956 (3 of 1956) or an equivalent qualification recognised as such by the Government;

(c) possess the basic knowledge of computer application as prescribed by the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 as amended from time to time in that behalf; (d) possess the minimum requisite standards of physique as specified in **Appendix A** appended to these rules; and

(f) possess adequate knowledge of Gujarati or Hindi or both.

5. A candidate appointed by direct selection shall be on probation for a period of two years.

6. (1) A candidate appointed by direct selection shall during his probation be required to-

(i) undergo pre-service training and to pass the post- training examination in accordance with the Gazetted Officers' Pre-Service Training and Examination Rules, 1970 as amended from time to time;

(ii) undergo police training and pass the police training examination; and

(ii) pass the qualifying examination for computer knowledge in accordance with the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006.

(2) A candidate appointed by direct selection shall be required to pass an examination in Gujarati or Hindi or both in accordance with the rules prescribed by Government in that behalf.

(3) The candidate appointed either by direct selection or by promotion shall have to undergo such training and pass post-training examination in accordance with the rules prescribed by Government in that behalf.

(4) A candidate appointed by promotion or by direct selection shall have to pass the departmental examination, if any, in accordance with the rules prescribed by Government in that behalf.

7. The candidate appointed by direct selection shall be required to furnish a security and surety bonds in such form, for such period and

for such amount as may be prescribed by the Government in that behalf.
